### **League Information**

USA Hockey Inc. is the national governing body for the sport of ice hockey in the United States. As such, its mission is to promote the growth of ice hockey in America and to provide the best possible experience for all participants, by encouraging, developing, advancing and administering the sport. SAHOF is to Florida, as USA Hockey is to the sport of hockey throughout the United States.

### **Season Information**

The 2011-2012 Travel Hockey Season will commence in August 2011 and continue through February 2012. Exact dates are to be determined by the BREAKERS organization and the League. The Pee Wee AA team will receive a total of 104 practice hours. Therefore, allowing approximately 4 practice sessions per week; (2) hours on Friday evening and (2) hours on Saturday morning. The league game schedule is determined by the League. Each team plays approximately 16 - 18 games per season; the exact amount is decided by the League. Games are usually scheduled every other weekend.

### **Tournament Information**

The Pee Wee AA team will participate in tournament play. The total number of tournaments will be decided with input from the coaching staff, management and parents. Tournament entrance fees are **not** included in the BREAKERS' program cost. The team will be assigned a Team Manager.

### **Coaching**

The Pee Wee AA team will be assigned (1) Head Coach and a minimum of (1) Assistant Coach. The Head Coach's salary is covered in the program cost.



### **Equipment/Apparel**

Each player will receive the following items:

- Practice jersey
- Practice hockey socks

Each player will be responsible for purchasing the following items\* (subject to change):

- Personalized home jersey and hockey socks
- Personalized road jersey and hockey socks
- Messier Project helmet or any HECC certified approved helmet (Dark Blue)
- Hockey shell
- Warm-up suit
- BREAKERS polo shirt with logo
- BREAKERS Hockey bag (optional)

### **Off-Ice Training Academy**

BREAKERS Off-Ice Training Academy is included for the Pee Wee AA team. The Academy consists of RapidShot membership and 120 minutes of RapidShot time; use of the gym and jump room facility with a coach present. The purpose of the OITA is to develop the total athlete within the hockey player. The OITA will specialize in off-ice conditioning.

### **Fundraising**

The Palm Beach BREAKERS organization is currently looking into potential fundraising endeavors for the 2011-2012 season. Fundraising opportunities have the ability to offset the program cost or may be applied to tournament entrance fees.
